WHAT WE COLLECT?

We may collect the following information:

- name and email address when you subscribe to be a member;
- occasionally a telephone number (when you enter a raffle for event tickets supplied by the Fan Club).

HOW WE COLLECT DATA?

We may collect personal data:

- When we meet you in person;
- When you subscribe online;
- When we speak to you by telephone;
- When you correspond with us by email or postal mail.

WHAT DO WE DO WITH THE INFORMATION WE GATHER?

We use the information to:

- Communicate with you;
- Send out a physical magazine;
- Send out special offers (ABBA/Fan Club related only);
- Send out a special newsletter (physical or by email).

WHO WILL YOUR INFORMATION BE SHARED WITH?

Your personal data will not be shared with any third parties. It will never be shared with third parties, except when needed when you entered a competition/lottery then we might have to send some personal data to help you further. If you enter a quiz/raffle/competition provided by the Fan Club, you agree that we give your name a mentioning in the magazine or on social media. SECURITY

We are committed to ensuring that your information is secure. It kept on a secured computer where administration is kept. And for a limited while it is on a secured server which collects details filled in on the website. The server use Security Sockets Layer (SSL) encryption technology to encrypt sensitive personal information. Credit card numbers are never stored on our database or servers.

COOKIES

We don't use any cookies on our website.

HOW LONG DO WE RETAIN YOUR INFORMATION?

We will retain your personal data for no longer than is necessary. When membership expires we keep it for another two years just in case you renew within that period.
